What is the overall <u>deductible</u> ?	\$2,000 individual/\$4,000 family combined network and \$4,000 individual/\$8,000 family combined out-of-network.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.	
Are there services covered before you meet your deductible?	Yes. <u>Preventive care services</u> benefits are covered before you meet your <u>network deductible</u> . <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward the <u>network</u> <u>deductible</u> .
